

Golden Shot – Terms and conditions

1. Promoter

The promoter is **LTA Tennis Foundation**, a registered charity (charity number **1148421**) whose registered office is **National Tennis Centre, Priory Lane, Roehampton, London, SW15 5JQ** (“the **Promoter**”).

2. Purpose

All net profits from this competition will be used to support the charitable purposes of **LTA Tennis Foundation**.

3. Competition Rules

- The competition shall run at each of those events listed in the schedule (the “**Events**”).
- The competition shall be open only to attendees at the Events (subject to eligibility criteria set out below at 4.).
- To participate entrants must attempt to hit a tennis ball using a tennis racket through the designated target holes.
- All entrants who achieve a score of 60 points will have the opportunity to win the prize.

4. Eligibility

- To take part in the competition, you must be a UK resident and aged **18 or over**.
- Employees, trustees, and immediate family members of the Promoter and all employees of the LTA (Lawn Tennis Association) are not eligible to enter.
- By entering, individuals confirm they meet the eligibility criteria.

5. Entry Fee

- The cost to enter is **£5.00** and this permits the entrant the opportunity to hit 5 tennis balls using a tennis racket at the target holes.
- By paying the entry fee, entrants are agreeing to be bound by these terms and conditions.
- Payment must be made prior to taking part in the competition.
- Pre-booking is not possible.
- Cash will not be accepted.
- Entry fees are non-refundable, including where an entry does not win.

6. How to Enter

- To enter the competition individuals must attend the Golden Shot activation on site at their Event, pay £5.00 for one entry and attempt to hit the tennis balls using the tennis racket provided, through the holes of the Golden Shot Target.
- One entry permits the entrant 5 hits.
- Individuals can enter as many times as they wish but the score shall only be taken from each entry – it is not possible to combine scores from multiple entries.
- The Promoter accepts no responsibility for unsuccessful attempts.

7. Winner Selection

- A winner will be selected at random from the entrants who successfully scored 60 points.
- See schedule for details of when a winner will be selected.

8. Prize

- For the tennis tournaments (see schedule), the prize is a pair of tickets to the finals day of the Event at which the entrant took part in the competition (see schedule for fuller details) and an opportunity to go onto centre court for an experience.
- For Trafalgar Square the prize is a £150 voucher to spend on Dunlop equipment.

- The centre court experience at all tennis tournaments except the HSBC Championships will be a hitting challenge against the Lexus tennis robot. At the HSBC Championships, it will be an opportunity go courtside.
- No cash alternative is available unless stated otherwise.
- The prize is non-transferable and non-exchangeable.

9. Winner Notification

- All entrants who score 60 points will be asked to share their name, a telephone number and an email address.
- The winner at the tennis tournaments (see schedule) will be notified via **email and phone** the day before the final at their Event.
- The winner of Trafalgar Square will be notified via email and phone on Tuesday 9th June.
- If the winner at the tennis tournaments (see schedule) cannot be contacted or does not respond within **one hour** of the notification, the Promoter reserves the right to select an alternative winner.
- You will not be notified if you have not been successful.

10. Publicity

- By entering, the winner agrees to the use of their name and/or image for reasonable promotional purposes related to the competition and the charity, unless they notify the Promoter otherwise.

11. Data Protection

- Personal data will be used solely for the administration of this competition and in accordance with the [Promoter's Privacy Policy](#).
- Data will not be shared with third parties for marketing purposes without consent.

12. Limitation of Liability

- The Promoter accepts no responsibility for any loss, damage, or injury suffered as a result of entering the competition or accepting the prize, except where liability cannot be excluded by law.

13. Changes and Cancellation

- The Promoter reserves the right to amend these terms and conditions or hold void, suspend, amend, or cancel the competition if necessary.
- The Promoter's decision is final.
- Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.

14. Governing Law

- These terms and conditions are governed by **English law**, and any disputes shall be subject to the exclusive jurisdiction of the courts of England and Wales.
